

As we have long shelf life food products (2 years+), where we must ensure food safety, we cannot transition any of our primary packaging to compostable options.

The closure of Redcycle has contributed to the challenges faced by Australia's plastic recycling system. Redcycle was a significant contributor to the recycling of soft plastics, which is the vast majority of our primary packaging, and its closure has left a gap in the recycling chain. The lack of other materials we can use or any options for alternate recycling of soft plastics means our packaging is now added back into the waste stream until a solution for soft plastic recycling in Australia is found.
